

Transportation Federal Credit Union Dare-to-Soar Writing Program OFFICIAL RULES

Transportation Federal Credit Union's Scholarship Committee reserves the right to select the recipients of the scholarship program based on the criteria set forth in the writing program description. If selected as a recipient, the applicant may or may not authorize the release of information regarding the essay, name, and images of recipient in media and marketing materials for publicity purposes. If the recipient is under eighteen years of age, the signature of legal parent or guardian of applicant is required for release authorization on behalf of the applicant.

Applicants must meet eligibility requirements. All applications will become the property of Transportation Federal Credit Union and may be used.

There will be one (1) Grand Prize available. The Grand Prize Winner ("Winner"), upon the Administrator's confirmation of eligibility, will receive a **\$3,500** gift card or deposit into Transportation Federal Credit Union base share account to be used towards a trip for two (2) with accommodations to the Annual EAA AirVenture event in Oshkosh, Wisconsin from July 22-28, 2024. There will be two (2) Runner-up Prizes available. The Runner-up Prize Winners, upon the Administrator's confirmation of eligibility, will receive a **\$500** gift card or deposit into Transportation Federal Credit Union base share account to be used towards tickets and ground transportation trip to Virginia Spaceport Authority in Norfolk, Virginia before December 2024.

The value of the Prizes set forth above represent Sponsor's good faith determinations of the ARV thereof and such determinations are final and binding and cannot be appealed.
